

**Legendary Run Homeowners Association**  
**Pool Party Request Process**  
**(Does Not Include Clubhouse)**

1. All requests are on a first-come, first-served basis. Pool Parties are not permitted Memorial Day Wkd, 4<sup>th</sup> of July Wkd, Labor Day Wkd, and the evening of the Summer Social.
2. A Pool Party Request Form is for the use of the pool only. It **DOES NOT** include the clubhouse.
3. First, obtain the Pool Party Request Form from one of the lifeguards or on-line from [www.legendaryruninfo.com](http://www.legendaryruninfo.com).
4. Fill out the form.
5. Hand the form directly to the lifeguard on duty.
6. The lifeguard will review the entire form with you.
7. The lifeguard will check that you have the correct number of guests (10-12), correct hours (the time should be between 4pm to 7pm) and a check for \$25.
8. The lifeguard will check the calendar in the pool information binder. If no one else is scheduled for that date, the lifeguard will write your family's name on that date. Only one party per day is allowed.
9. There are 3 folding tables and 12 folding chairs for your use during the party. You are responsible for setting them up and cleaning/taking them down at the end of the party. You also need to bring trash bags to haul away your party trash. Unfortunately, we do not have the space to take the trash.

The Homeowner agrees to end the event promptly at the designated time. The Homeowner agrees to clean and remove all trash from the Pool area and haul it away with them. The Homeowner agrees to be responsible for any damages that occur during the event and assures that all Pool rules are followed. Charges for damages will be equal to replacement cost.

***INDEMNIFICATION OF THE ASSOCIATION***

In consideration of any use of the Association Pool, I agree to defend, indemnify and hold harmless the Association from and against any and all liability, including all court costs and attorney fees, incurred by the Association as a result of any claim, demand or cause of action for personal injury or property damage arising out of my use of the Pool on the day or evening specified in this Agreement.
